

## NOTICE OF PUBLIC HEARING

Notice is hereby given that the Housing Finance Authority of Volusia County, Florida (the "Authority") will hold and conduct a public hearing on March 25, 2022, at 4:30 p.m. or as soon thereafter as such matters may be heard, at the offices of Smith Bigman Brock P.A., 444 Seabreeze Blvd., Suite 900, Daytona Beach, Florida 32118 and by phone due to COVID-19 by calling (877) 783-2009, Passcode 323377 on the following:

The proposed issuance by the Authority of its Multifamily Housing Revenue Bonds (Clyde Morris Landings Apartment Homes – Phase V) Series 2022, in an aggregate principal amount of not to exceed \$24,000,000 in one or more series, the proceeds of which will be used to finance the acquisition, construction and equipping of an approximately 227-unit multifamily rental housing facility for persons or families of moderate, middle or lesser income within Daytona Beach, Volusia County, to be located approximately 2,072 feet south of the intersection of N. Clyde Morris Boulevard and LPGA Boulevard, Daytona Beach, Volusia County, Florida (the "Clyde Morris Landings Apartment Homes – Phase V"). Clyde Morris Landings Apartment Homes – Phase V will initially be owned and operated by Clyde Morris Phase V Partners, Ltd., a Florida limited partnership, or one of its affiliates, the initial general partner of which will be SAS Clyde Morris Phase V Managers, L.L.C. with its sole member being Southern Affordable Services, Inc., a Florida not-for-profit corporation.

All interested persons are invited to attend said hearing in person or by phone and, either personally or through their representatives, present oral or written comments and discussion concerning the proposed issuance of the above-described bonds to finance the acquisition, construction and improvement of the above-described projects and the nature and location of the above-described projects. Written comments may be submitted to the Housing Finance Authority of Volusia County, Florida, c/o Smith Bigman Brock P.A., 444 Seabreeze Boulevard, Suite 900, Daytona Beach, Florida 32118. Should any person decide to appeal any decision made by the Authority at this hearing, or by the Volusia County Council with respect to the approval of the issuance of the above-described bonds to finance the above-described projects, he or she will need a record of the proceedings, and he or she may need to insure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
